



## RENTAL POLICIES

**Georgia Expo Mfg. Corp. agrees** (1) to provide a photo backdrop from our library of your choosing for the duration of the agreement; (2) to ship the photo backdrop to arrive on the date specified in our agreement; (3) to provide a return label and return packaging for you to send back the photo backdrop on the agreed upon date; (4) to clean and properly store the backdrop after each use.

**Client agrees to** (1) inspect backdrop upon arrival; (2) utilize backdrop in an indoor environment; (3) install the backdrop using appropriate and safe equipment (we recommend our Portable Pipe and Drape Hardware Only Kit + Hard Case) (4) be responsible for any damage to the backdrop incurred while in their care or people they allow to handle the equipment (5) to return the backdrop on the contracted day.

**Liability** The client is liable for Georgia Expo products while in their possession. Client agrees to release and hold harmless Georgia Expo Mfg. Corp. from any claims, actions, suits, costs, damages or liabilities including but not limited to liability for personal injury of any person at the event or property and/or in the case of wrongful death.

**Payment** for one time rental is due upfront. Payment can be made by credit card or checks made to Georgia Expo Mfg. Corp 3355 Martin Farm Rd. Suwanee, GA 30024

**Late** Our rentals are in HIGH demand. It is extremely important that the products be returned promptly. Late returns will be billed at \$25/day up to the cost of the backdrop not exceed \$500.

**Cancellations** We understand that sometimes plans may change. Rental service can be canceled and refund issued up until 2 business days prior to the backdrop shipping out. Orders canceled less than 2 business days prior to the scheduled date of shipment are subject to the full rental rate (fee).

**Damage** Georgia Expo inspects every backdrop before we send them to you. You will receive a notification on the condition of the backdrop prior to shipment, we expect the backdrop to be return to us in the same condition. You are responsible for any damages or loss.



## RENTAL AGREEMENT

### *Terms & Conditions*

This Rental Agreement Terms and Conditions ("Agreement") specifies the terms and conditions for the rental of backdrops provided by Georgia Expo. ("Us" or "We" or "Our"). Please review this Agreement and its terms and conditions carefully.

**Indemnity.** Renter ("You" or "Your") agree to defend, indemnify, and hold Us harmless from and against any and all claims, actions, causes of action, demands, rights, damages of any kind, costs, loss of profit, expenses and compensation whatsoever including court costs and attorneys' fees ("Claims"), in any way arising from, or in connection with the products rented (collectively, the "Product"), including, without limitation, as a result of its operation or use, maintenance, or possession, irrespective of the cause of the Claim, except as the result of Our sole negligence or willful act.

**Loss or Damage to Product.** You are responsible and agree to indemnify Us for any loss, damage or destruction of the Product, including, without limitation, loss or damages occurring while Packing and unpacking, while at any and all locations, while in storage and while on Your premises, except that You shall not be responsible for damage to or loss of the Product caused by Our sole negligence or willful misconduct. Any loss or delay in shipment and any damages resulting therefrom shall be Your sole responsibility. In the event of loss or damage, You are also responsible for Our loss of use of the Product during the time it is being replaced, as applicable. A damage insurance may be purchased to cover all damages except loss or damage by Your willful act or gross negligence.

**Lease Term and Rental Fees.** The lease term and rental fees for the Product rented by you shall be stated on your order.

**Blanket Rental Agreement.** From time to time on a continuing basis, we will rent/lease our Products to you. As to each and all such Products rented by you, you agree to be bound by all of the terms and conditions of this Agreement. For each rental, the following items shall be provided in your order:

- a. Term of the rental.
- b. Item ID & Description.
- c. Rental rate.
- d. Item condition.

**Rental Fees.** The following additional fees are subject to change without notice and shall apply to each order placed with Us: Shipping and Handling Fees. You are responsible for returning the Product to Us by the order due date and at the location specified by us on your order.

**Duty to Inspect.** You will inspect the Product before your first use. Unless you give written notice to us specifying any defect in or other proper objection to the Product, you agree that it will be conclusively presumed that you have fully inspected the Product and acknowledged that the Product is in good condition and that you have accepted the Product in that good condition.



**Valuation of Loss.** In the event of damage or total loss, You shall be responsible for the full replacement value of the Product in addition to the rental fee. In no event shall We be liable for any consequential damages.

**Return.** We will provide a return label and return packaging for you to send back the Product on the agreed upon date, by the due date listed on Your order, free from all damage and in the same condition and appearance as when received by You.

**Late Fee.** If You return the Product to Us after the due date specified on your order, You agree to pay us a late fee.

**Applicable Law.** This Agreement will be deemed to be executed and delivered in Los Angeles, California and governed by the laws of the State of California.

**Amendment or Modification.** This Agreement may not be amended, modified, or altered in any manner except in a writing signed by both parties.
